Conference Welcome and Opening Prayer

Larry H welcomed the conference and introduced the history of Pills Anonymous. In 2008, approximately 50 groups were meeting as a loose confederacy of meetings without an official structure. Originally, the meetings were using the AA big book as a basic text. *In the Solution* was published and the structure of PAWS was created.

Three parts of PAWS are represented by this conference – PA World Service Inc., PA World Service Office, PA Trustees. Larry H encouraged all to participate and join a committee. The committees are as follows:

An overview of each committee was reviewed for the conference.

Delegates are present at this conference representing meetings in their local areas. As a delegate, this person is present as a representative of their group. A delegate has the responsibility to vote as a representative of their local group. Delegates are elected by every meeting. Each group elects one delegate and one alternate delegate.

The PAWS committee has the power to change anything except the steps and the traditions.

#### **PAWS World Service Office**

Lisa reported on the business office. There are currently approximately 8 people who assist with the office. The duties of the PAWS world service office were reviewed. The key tags and book were created by the world service office. A duty of the world service office includes ensuring that the books and key tags are from the PAWS World Service Office. Delegates and groups may also seek assistance through this the world service office. See the manual and website. The World Service Office is striving the answer the calls and emails from groups and potential members.

### **PAWSO Treasurer Report**

PAWSO has earmarked startup funds to repay PAWS inc for seed funds to write the book. In 2015, the income collected exceeded the expenses. The excess money is sent to PAWS Inc. to repay the seed money. This repayment is begun only after a prudent reserve is created. This can be seen under the line item of Payment to PAWS inc.

Overall sales of the book, *In the Solution*, and key tag sales have decreased. This may be because there was a lead up to the sales of the book and key tags. The shopping cart feature of the website was redesigned. The old shopping cart was difficult to maneuver and has now been remedied.

#### **Common Welfare Committee**

Wanda reported for the Common Welfare Committee. A tri-fold flyer was created and distributed for review by Wanda. "A Higher Power" pamphlet was presented to the conference. This pamphlet was read for the conference as introduction to "A Higher Power" pamphlet. Later in the day, this pamphlet will be voted and decided upon.

Nomenclature – Wanda reminded the group that the preference is "P.A." not PA or pa.

There was a suggestion to modify some of the language. The changes include:

- Change "we came here in our darkness hours" may be changed to "we came here at our darkest hour". This was wording was run through Wikipedia and deemed to be appropriate in the first sentence.
- The sentence with "recovered from their addiction", this can be changed to "they are recovering from their addiction".

Wanda will incorporate changes and resubmit to the committee.

### **Organizational Committee**

Larry reviewed the organizational committee. We should begin utilizing "Pills Anonymous" in lieu of "P.A." as not to become confused with other groups. A history of Pills Anonymous was reviewed. The original delegates are no longer active after eight years. They are being phased out. This change will be reflected in the Pills Anonymous service manual. Please join the organizational committee – see Larry.

### **Public Information / Internet Committee**

Carrick reported on the "Start A Meeting" tab. Groups are utilizing this tab and information is being passed between groups and the committee. New meetings are starting.

A new shopping cart tab was created and redesigned for purchases through the website.

New content and meetings have been updated and continue to be updated.

New literature is posted online.

Mobilization updates were added.

Usage has remained steady with unique users and length of time spent on the PA.org website.

Office 365 was integrated into PAWS. This is a cloud based computer environment complete with shared calendars. Meetings online with skype business.

Carolyn reported about her relationship with the scanner. What are you scanning? Minutes from the meetings, changes to the world service manual, etc. This includes conference meeting minutes and agendas. These notes will be available for future prosperity.

#### **Board of Trustees**

Larry introduced the trustees. The length of a term is for four years. Trustees cannot serve more than two terms consecutively. The number of trustees must be at least four – this is an IRS requirement for a 501(c)3 status. There are requirements for trustees include willingness to serve, commitment to service, a minimum of 5 years of clean time, and prior service to PA conference. The Board of Trustees will meet twice a year, sometimes meetings are via telephone conference and at the PAWS conference.

Randy M, Wanda, Chris, Janice, Shea, Ron, Larry are current members.

A non-addict board of trustee is also needed.

As an example: There was a Facebook group that began using P.A. logo and trademark. There were interactions between our Board of Trustees and the group leaders.

The idea of skyping into the conference was discouraged due to the difficulty of long distances.

Wanda moves to accept this pamphlet with the suggested changes. Larry seconded motion. After some discussion, the motion removed.

Discussion included changing the PA to P.A. in other literature. Should we also consider ensuring that all literature have the same formatting.

Common Welfare Committee will meet to discuss changes and propose a new version of the pamphlet "A Higher Power". Tabled until after the break.

The Common Welfare Committee reported that changes and suggestions are appreciated from the conference.

One of the goals for next year include creating a short pamphlet to get the service manual information out to the groups. Get the information to schools and police stations. This trifold pamphlet will incorporate best practices for dissemination of public information.

#### **Conference Committee**

Sheryl will begin as secretary.

Chris moves that the conference will be held 8/19, 8/20, 8/21 and back up dates for the following weekend.

Another idea was to contact ASU and other schools. The issue of how to approach high schools and universities was spoken to. There seems to be a need to get out recovery pamphlets and literature. The H&I Committee plans to reintroduce P.A. to institutions.

#### **Public Information**

Monica will chair the Public Information Committee for 2015. One goal is to create a pamphlet for next year. The name for the pamphlet is titled "SPREAD THE WORD!". By middle October Monica will finish a first draft and send to the committee members. Committee members will send edits to Monica. This pamphlet will be posted on the website.
